

ROAD TRAFFIC BILL 2018



Anyone driving on the roads of Mauritius recently will have already seen the impact of this new Bill introduced in July 2018. The police are highly visible with more mobile radars and the traffic laws have been strengthened to provide for tougher penalties:



- The number of offences for fixed penalty notices goes from 141 to 204.
- The fine for speeding at more than 25 km/h above the authorized limit will increase from Rs 2,000 to Rs 10,000.
- Fines in respect of driving while under disqualification, driving without a licence and authorizing a person prohibited from driving by reason of age to drive, will be increased from Rs 10,000 to Rs 100,000



- After committing three Cumulative Road Traffic Offences, a driver will receive a notice informing him that if he commits two more offenses, his license will be suspended for a period of six months to two years.
- A zero tolerance policy will be applied with respect to drinking and driving.



As a consultant in forensic medicine the former Chief Police Medical Officer and Member of Parliament, our speaker, Satish Boolell was of the opinion that the Act was poorly drafted. In particular he noted that the policy on drink driving was impossible to enforce and posited that it would not be long before it was challenged in court. He pointed out the many loopholes and in a humorous way suggested ways to avoid being caught. As always Satish was able to make a very serious topic entertaining and was more than happy to answer questions from the audience. members were very vocal and expressed many concern with the way the new laws were being enforced.
